Laurajo Ryan

Ryan named Educator of the Year

Dr. Laurajo Ryan, clinical associate professor of pharmacotherapy, is recipient of the College's 2015 Educator of the Year award. Ryan was named to receive the honor at the recent, student-coordinated spring social. Other faculty honored at the event include, Dr. Bill Williams, professor of pharmaceutics, recipient of the first year (P1) teaching honor; Mr. Jim Koeller, professor of pharmacotherapy, recipient of the second year (P2) teaching honor; and Dr. Chris Frei, associate professor and division head of pharmacotherapy, recipient of the third year (P3) teaching honor.



James McGinity

McGinity is UT's Inventor of the Year

Dr. James W. McGinity is one of two faculty members named as 2014 UT Austin Inventors of the Year. Dr. George Georgiou, from the Cockrell School of Engineering, was named as co-recipient at the Inventor Award Ceremony in November. McGinity, the Johnson & Johnson Centennial Chair Emeritus in Pharmacy, devoted his career to making sure that medicines are effectively administered to patients. Medical experts say McGinity's work with OxyContin is not only promoting appropriate use of the powerful painkiller but also saving "countless lives" by cutting down the potential for abuse.



Walter Fast

Fast awarded \$2.1 million to counter antibiotic resistance

Dr. Walter Fast, associate professor of medicinal chemistry, has been awarded a four-year \$2.1 million grant from the National Institutes of Health (NIH) to develop small-molecules that counter antibiotic resistance in Gram-negative bacteria. If successful, the research could lead to new drugs for clinicians to use in treating bacterial infections that are resistant to most antibiotics. Fast is studying a class of enzymes, called metallo-beta-lactamases, that confer resistance to almost all clinically-used beta-lactam antibiotics, including penicillins, cephalosporins, and even carbapenems that are often used as 'drugs of last resort' for treating resistant infections.



John DiGiovanni

CPRIT grant to support DiGiovanni's skin cancer research

Dr. John DiGiovanni, professor of pharmacology and toxicology, has been awarded a \$900,000 grant to study the role of a protein, Twist1, in the development of nonmelanoma skin cancer (NMSC). The award was made by the Cancer Prevention and Research Institute of Texas (CPRIT). DiGiovanni's award was one of 54 statewide awards announced by CPRIT in mid-February including four for product development and 51 grants for academic cancer research.



Lydia Aguilera

Aguilera receives mentoring award

Dr. Lydia Aguilera, assistant dean for the college's Cooperative Program in the Rio Grande Valley, has been named recipient of the 2015 College Excellence Award in Mentoring for the College of Health Sciences and Human Services (COHSHS) at The University of Texas-Pan American. Aguilera, who also serves as a clinical assistant professor, works for the college on the Pan American campus. She was formally recognized with a plaque and a \$1,500 stipend at the Faculty excellence Awards Luncheon on May 1.



Solomon Stavchansky

Stavchansky joins Kentucky's distinguished alumni

Dr. Salomon Stavchansky, professor of pharmaceutics, is one of four named to the Hall of Distinguished Alumni at the University of Kentucky's College of Pharmacy. Stavchansky, who received his Ph.D. in pharmaceutical sciences from the UK College of Pharmacy in 1974, has directed and participated in research concerning the development of analytical methodology for the measurement of drugs in biological fluids; the absorption, metabolism, distribution, and elimination of drugs from biological fluids in animals and man; and the evaluation and design of drug delivery systems.

Brown elected to UT's Faculty Council

Dr. Carolyn Brown, professor of health outcomes and pharmacy practice, has been elected to the university's Faculty Council. She was one of ten professors and associate professors from throughout the campus selected in the Spring 2015 election. The Council is one of two governing bodies representing the faculty.

College mourns Creed Abell III

Dr. Creed W. Abell III, the Henry M. Burlage Centennial Endowed Professor Emeritus, died September 9, 2014. Dr. Abell was internationally recognized for his contribution to neurochemistry and neurobiology. His work contributed to the scientific information and understanding regarding diseases such as Parkinson's and Alzheimer's and to the understanding of how aging affects neurological function.


Mootz receives RESPy Award
